







Figure 1. Typical Variation of Forward Current vs. Forward Voltage




Figure 4. Typical Capacitance Curve as a Function of Reverse Voltage




Figure 2. Typical Forward Conduction Curve




Figure 3. Typical Variation of Reverse Current at Various **Temperatures** 


